¹ District student enrollment data for students identified as English Learners (ELs) is sent to WIDA AMS in precode files and is used for printing student labels and loading students for online testing. This date may be earlier if you use a Student Information Service (SIS) provider; check with your provider for dates. The precode file is sent on Dec. 12 and includes all ELs identified in student enrollment data submitted to MDE. **Note: This date is earlier than the final MARSS submission; collaborate with your MARSS coordinator to ensure student enrollment data is updated prior to the MARSS deadline.**

² For WIDA ACCESS and WIDA Alternate ACCESS, this date must be followed to ensure that all paper tests can be scanned and scored before data is provided to MDE. If scorable test booklets (WIDA ACCESS for Kindergarten, WIDA ACCESS Writing, or WIDA Alternate ACCESS) are not returned by this date, assessment records may not be provided for Posttest Editing, scores may not be available for accountability calculations, and an Individual Student Report (ISR) may not be provided with the shipment of reports.
